- I agree that the animal is being adopted for myself and will not be sold, adopted, or given to another party. _____ (initial)

- I agree to provide the adopted pet with necessary vaccinations at the intervals advised by my veterinarian and other medical care, preventative medications and grooming as needed. - If at any time I find I cannot keep the pet for any reason, I understand I must return the pet to BMFH Rescue. _____ (initial)
- I understand and agree that the current rescue makes no guarantees about the animal's temperament and is not responsible for future damages or injuries caused by the animal. _____ (initial)
- I give the current rescue permission to call me at any reasonable time to assure that the animal is being properly treated and cared for. _____ (initial)
- I agree that all statements I have made on this form are true. If it is found that any statements I have made on this form are not true, or any failure to perform the foregoing agreement, the adopted animal can be confiscated. _____ (initial)
- I agree that the adoption donation of \$_____ is non-refundable even if the dog is returned to BMFH Rescue, and that BMFH Rescue is adopting not selling this pet to me. _____(initial)
- I agree that I will never sell, trade, or give away this pet to anyone. I will never relinquish this pet to any shelter or pound. I will notify BMFH Rescue if I am unable or unwilling to keep this pet, and I will return this pet to BMFH Rescue. If this pet should become lost or stolen, I will notify BMFH Rescue within 24 hours. _____ (initial)

Be My Forever Home Animal Rescue Effort - Companion Adoption Application/Contract

- I agree that if this animal is unaltered, I will have the animal spayed/neutered within _____ days. I understand that failure to get this animal spayed/neutered within the specified time frame will result in forfeiture of my animal and any adoption donation given. I will also be subject to pay a \$100 administration fee as well as face possible legal action. _____ (initial)
- If my animal is not microchipped at time of adoption, I agree to microchip them no later than at time of spay/neutering: _____ (initial)
- I will buy and use a crate if needed and/or advised. The dog will be primarily indoors interacting with our family, not to be banished to the backyard. I will never tie my dog to a chain or leave him/her unattended for long periods of time. This is a companion animal, not a possession. I will not transport this animal unconfined in an open vehicle. _____ (initial)
- I will protect this pet with annual vaccinations and routine medical care as recommended by a veterinarian. Dogs must be kept on monthly heartworm preventive year round. I will seek immediate veterinary care if this pet becomes ill or injured. _____ (initial)
- If it is recommended by a veterinarian to euthanize this pet, approval must be obtained from BMFH Rescue PRIOR to the procedure. _____ (initial)
- I will comply with all state and local ordinances in the confinement, care, and licensing of this pet. I will reclaim this pet promptly and pay any required fees if it is picked up by an animal control agency. _____ (initial)
- I agree to allow a visit/call by any BMFH Rescue representative at a mutually agreeable time at any time after this adoption to verify the wellbeing of this animal. _____ (initial)
- I understand that BMFH Rescue makes no guarantees regarding the age, nature, temperament, or health of this pet. By signing this contract, I assume all risk and responsibility of ownership of this pet once it is in my possession. I agree to defend, indemnify, and hold harmless BMFH Rescue and its representatives against any and all claims including claims of property damage and/or personal injury, which arise from my adoption of this pet. _____(initial)
- I agree that if I fail to comply with the terms of this contract, I will voluntarily relinquish this pet to BMFH Rescue. _____(initial)
- Should I fail to perform, according to the terms contained in our Adoption Contract, BMFH will pursue all remedies available to it.
